CHILI BOOTH APPLICATION & OFFICIAL RULES



1. Contestants check-in/register at Fog Willow Pumpkin Farms starts at 7am. No Set-Up allowed after 9:00am.
2. Cooking of chili will begin after registration. All chili samples for judging will be picked up at 11:00am. Judging of the chili will begin at 11:30am with the winner announced at 3:00pm. Chili booth holders can begin vacating their site beginning at 3:00pm.
3. Contestants are responsible for supplying their own cooking stove (preferably propane), NO POWER WILL BE PROVIDED, all utensils, serving table, all ingredients for their chili and plenty of good humor.
4. Each contestant will be assigned a number and a pint container. The container will be collected at the time of judging. The decision of the judging shall be final.
5. Contestants must make at least 10 gallons of chili to allow for judging and chili kit tasting.
6. All ingredients MUST be assembled and cooked on-site due to health considerations.
7. Meat may be precooked and vegetables precut. No clean-up will be available on-site.
8. Chili kits (Spoons, bowls & napkins) provided by the WFA.
9. Chili Cooking Only-- no sales allowed from booths.
10. Amateur's only. No professional cooks.
11. Due to insurance requirements, no personal alcoholic beverages are allowed on the premises during this event.

Participant's Waiver, Release, Assumption of Risk and Indemnity Agreement

for Wilton Firefighters Association Chili Cook off & Classic Car Show on August 26, 2017

This form is a contract with legal consequences. Read carefully before signing. If waiver is not signed, participant will not be registered and form will be returned.

In consideration of the acceptance of the registration form for the program listed, the participant (s) name on the form freely agrees to and makes the following contractual representations and agreements:

1. The participant named has read the official rules and eligibility standards and understands the nature and content of the activities involved, and any potential dangers incidental to engaging in the activities.
2. The participant named hereby voluntarily releases, discharges, waives and relinquishes any and all actions or causes of action for personal injury (including death) or property damage occurring to himself/herself arising as a result of participating in the said program or any incidental activities.
3. The participant named agrees that under no circumstances will he/she or his/her heirs, executors, administrators, and assigns prosecute, present any claim for personal injury (including wrongful death) or property damage against the Wilton Firefighters Association or any said persons, whether passive or active.

IT IS THE INTENTION OF THIS INSTRUMENT TO EXEMPT AND RELIEVE THE WILTON FIREFIGHTERS ASSOCIATION FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONG DEATH CAUSED BY NEGLIGENCE.

4. The participant named further agrees to defend, indemnify and hold harmless the Wilton Firefighters Association, their officers, employees and volunteers, from any claims, demands, damages, costs, expenses, or liability arising out of his/her participation in said activities.
5. The participant named acknowledges that he/she has been fully and completely advised of the potential dangers incidental to engaging in the activities, and fully and voluntarily assumes the risks of engaging in the program and activities.
6. The participant named has read this form carefully and is fully aware of the legal consequences of signing it.

The Wilton Firefighters Association does not have or provide medical or accident insurance for persons involved in programs sponsored by the Wilton Firefighters Association.
